

The 2021 Convention and Trade Show is right around the corner, and we want to make sure that you have all the information you need prior to your arrival. We have compiled a list of frequently asked questions to make your Convention experience as smooth as possible.

### **What is required to enter the Edmonton Convention Centre (ECC)?**

Anyone participating in Convention will need to provide proof of double vaccination, a negative, privately-paid for test result within a 72-hour window, or an original copy of a medical exemption letter. One of these three will be required each time you enter the building.

Starting on November 15<sup>th</sup>, the government issued QR Code will be only proof of vaccination accepted. A paper copy or PDF of proof of vaccination will NOT be permitted. We encourage you to have your QR code or negative test result, along with picture ID, readily available when you arrive at the venue to ensure a smooth and quick entry to the facility.

### **How do I get a QR code?**

Getting a QR code is quick and easy. Visit the [Alberta Covid-19 records website](#), fill out the information, and save it or screenshot it to your phone. You will require your Alberta Health Care number along with the month that you received either of your vaccine doses.

### **What happens if I arrive and do not have a QR code?**

You will be required to visit the website and download your QR code before you are permitted into the building. We will have staff on-hand to assist, but it will slow down your entry to the building. We strongly encourage you to download it prior to your arrival.

### **When will masks be required?**

While the venue is following the REP Program guidelines, indoor masking is required throughout the facility. Attendees will be required to wear masks at all times while walking through the building, including trade show, and masks will be required in breakout sessions.

Masks can be temporarily removed if you are seated at a table consuming food or beverage, or standing at a table consuming food or beverage. Food or beverage must be consumed at a table. If you are not consuming food or beverage, you must put your mask back on, even while seated at a table. We appreciate your understanding.

### **What other measure will be in place?**

The ECC has implemented enhanced cleaning measures that will be in place throughout the event. Attendees will receive hand sanitizer and wipes upon arrival, as well as one disposable mask. Utensils used on buffet lines will be changed frequently, and hand sanitizing will be mandatory before attendees can go through the buffet lines. Masks will also be mandatory at buffet lines.

Attendees will also receive three stickers upon arrival: red – *please greet me from six feet away*, yellow – *I'm comfortable with handshakes and high fives*, and green – *all of the above, and open to hugs*. We encourage you to pick the sticker that best reflects you and place it on your name tag. This will allow your fellow attendees to greet you in the way that makes you feel the most comfortable.

### **What else is coming my way?**

Tomorrow, all registered attendees will receive emails from two external sources: CrowdCompass and Simply Voting. The CrowdCompass email will contain your login details for the Convention App, and we encourage you to login in to customize your profile prior to arriving on-site. The Simply Voting email will contain your voting details (if eligible) and will contain a test vote that needs to be completed PRIOR to voting onsite.
