

Appointment to Council Policy

1. Introduction

The Safety Codes Council (Council) is comprised of **members** appointed by the Board of Directors (Board) and the Minister of Municipal Affairs (Minister), in accordance with the Safety Codes Act (Act).

Members appointed by the Board are recommended for appointment by the nominating organizations specified in sub-council specific matrices.

The 12 sub-councils represent key industries and stakeholders and provide discipline-specific expertise to the Board, President and Chief Executive Officer (CEO), and Council administration in the areas of codes and standards, certification, accreditation, and training.

2. Purpose

The purpose of this policy is to establish the requirements for the appointment of individuals to Council and approval of Council membership matrices.

3. Definitions

expert: the term "**expert**" is to be interpreted broadly and generously. It is not necessary to be a technical **expert** in a discipline. Rather the member has knowledge and experience that is of value to the discussion of codes and standards, accreditation, certification, training or other matters. Examples of non-technical **experts** include risk managers, the public at large, consumer protection, real estate management, and the insurance industry.

member: means an individual appointed to the Council by the Board or the Minister.

4. Policy

Matrices

- 4.1. The Board will establish membership matrices for the 12 sub-councils. The approved sub-council membership matrices are specified in Appendix A.
 - 4.1.1. Membership matrices will be structured by industry segment and corresponding nominating organization.
 - 4.1.2. Each sub-council will include a public **member** appointed by the Minister.
 - 4.1.3. The membership matrices will include **experts** who are:
 - 4.1.3.1. representatives of municipalities, business, labour, and persons with





disabilities; and

- 4.1.3.2. from amusement rides, buildings, barrier-free building design, electrical installations, electrical transmission and distribution, elevating devices, fire protection, gas systems, passenger ropeways, plumbing systems, pressure equipment, and private sewage disposal systems disciplines.
- 4.1.4. The membership matrix may also include:
 - 4.1.4.1. representatives of educational institutes;
 - 4.1.4.2. safety codes officers; or
 - 4.1.4.3. parties that create risk in the safety codes system (owners, designers, manufacturers, contractors, and vendors) as identified in sections 5 to 9 of the Act.
- 4.2. Each sub-council will review its membership matrix annually and ensure the industry segment and corresponding nominating organization remain current and relevant. The annual review of a matrix will ensure that:
 - 4.2.1. the industry segment and its corresponding nominating organization remain current;
 - 4.2.2. it reflects and represents the discipline for which it was established:
 - 4.2.3. duplication of an industry segment is avoided;
 - 4.2.4. the contribution of each **member** remains valuable, and is evaluated accordingly;
 - 4.2.5. industry segments not represented, but would add value, are identified and assessed; and
 - 4.2.6. groups or individuals who would bring a relevant, unique, and valuable perspective are encouraged to participate.
- 4.3. Changes to an existing matrix may be initiated by a sub-council.
- 4.4. The Board, where it considers necessary and appropriate, may amend the matrices of the sub-councils. When the Board amends a matrix, it will provide its rationale to that body at its next meeting.

Appointment of Members

4.5. The Board will consider, and where appropriate, appoint or reappoint individuals to Council that have been nominated for appointment by the representative bodies or nominating organizations specified in sub-council specific matrices and that have



been recommended for approval by a sub-council.

4.6. The Board may terminate the appointment of a **member** appointed by the Board. Grounds for termination include: violation of the Council's Code of Conduct and Ethics Policy, non-attendance for meetings (three consecutive times), non-participation in voting (including letter ballots), and the request of a nominating organization for a replacement member. The Board may request the removal of a public **member** through the submission of a formal request to the Minister.

5. Authority

This policy is established under the authority of Sections 16(1) and 19 of the Act and Articles 6.2 and 7.2 of the Council's Bylaws.

6. Scope

This policy applies to members.
