
## **About Resolutions**

ABmunis conducts an annual resolutions process that enables member municipalities to bring forward common issues and solutions and seek member approval to give direction to ABmunis' Board of Directors to advocate to the federal and provincial governments on members' behalf.

When a resolution is adopted by members, ABmunis takes action to develop and implement an advocacy strategy that is specific to each resolution based on its level of priority.

Adopted resolutions are considered active for three years. For detailed information on each of the 2024 resolutions, refer to the <u>2024 Resolutions Book</u> or ABmunis' <u>Resolutions Library</u>.

## What happens after a resolution is adopted?



Note: ABmunis' advocacy strategy will differ depending on the priority of the issue. If the Board deems a resolution to be a low priority, ABmunis will monitor the issue but may not take other action after sending the initial letter to the government (step 4). Whereas a resolution that is considered a medium or high priority may lead to an advocacy strategy such as sending additional letters, seeking a meeting with a minister, premier, or senior staff, conduct research, strike an ad hoc working group, collaborate with other stakeholder organizations, engage media, conduct a public social media campaign, encourage members to take specific action, or other initiatives.
